I herewith acknowledge and agree that:

- 1. I am bound to and shall comply with Book 6 FIBA IR, including any regulations referred to therein (e.g. FIBA Statues, Books 1-5 FIBA IR to the extent applicable, including FIBA's Code of Conduct Book 1 FIBA IR, FIBA's anti-doping rules Book 4 FIBA IR, 3x3 Rules of the Game, Pro Circuit Handbook and Branding Guidelines) (together the "Regulations"), as in force and published at the time of the Competitions, and with any decisions issued by FIBA and its bodies and divisions (jointly "FIBA") based on the Regulations. My participation in the Competitions is conditional upon my valid acceptance of and compliance with each and every provision of this Entry Form and the related Competition participant protocol, if any. I am aware that violating the Entry Form may harm other players, including my teammates (e.g. a sanction may affect the entire team).
- 2. I shall respect (and have respected during the 3x3 Season) the spirit of fair play, clean game and non-violence in any discipline governed by FIBA and I shall behave (and have behaved during the 3x3 Season) accordingly on and off the court.
- 3. If I violate clause 1. or 2. above, FIBA may sanction me not only in accordance with the Regulations, but also deduct part or all of my FIBA 3x3 Individual World Ranking points, exclude me from the Competitions and/or provisionally or permanently exclude me from play.fiba3x3.com depending on the seriousness of the violation. In addition, the 3x3 Supervisor (or his delegate, if any) may decide whether any game in which the violation occurred shall be forfeited and whether I (personally or along with my team) shall be banned from further participation in the Competitions in which the violation occurred. Within 1 hour after I have been notified of any such decision, I shall have the right to appeal to FIBA by contacting the 3x3 Supervisor or the 3x3 Managing Director. The decision will be taken by the relevant body of FIBA and I shall have the right to be heard before a decision is made. I am aware that in the event an appeal against a decision taken by the FIBA 3x3 Supervisor is rejected, in whole or in part, I may be liable to pay the costs of the appeal proceedings to FIBA.
- 4. I acknowledge that any and all results of testing or other related health data including pathology and specialist reports may be collected by FIBA or medical personnel engaged by FIBA ("Personal Data"). My national federation may forward my personal data to FIBA for use in anti-doping matters. I have read the players' information notice regarding doping-control related data and hereby consent to the processing of my personal data in accordance with the applicable anti-doping regulations.
- 5. I participate in the Competitions at my own risk and I will take all reasonable measures to protect myself against the risks of participation. I am responsible for all property I bring into the Competitions. I am responsible for obtaining medical and general liability insurance (if any) covering my participation in the Competitions; neither FIBA nor the organizers of the Competitions will contract any such insurance for me.
- 6. While FIBA provides the framework for the Competitions, the events that comprise the Competitions are organised under the exclusive responsibility of the respective organizer.
- 7. To the extent permitted by law, FIBA (and its respective members, directors, officers, employees, volunteers, sponsors, contractors or agents) shall not be liable for any loss, injury or damage that I may suffer in relation to my participation in the Competitions.
- 8. In consideration of the acceptance of my participation in the Competitions and of the benefits linked thereto,
 - a. I agree to be filmed, televised, photographed, identified and otherwise recorded at the Competitions. I acknowledge FIBA's right to use such material as detailed in the Terms and Conditions of play.fiba3x3.com to which I herewith agree; this includes potential use of my name, likeness, autograph and other identifying characteristics in e-games, fantasy games, predictor games and NFTs.
 - b. I shall abide by the rules applicable to the Competitions in relation to advertising as well as apparel (uniforms and accessories). In Pro Events, if I am provided free of charge by FIBA with apparel (the "Apparel"), I shall wear it at all times from head to toe; this obligation does not extend to shoes. I understand that I am not entitled to wear in Pro Events any other apparel (except for shoes) and that I am not allowed to place on the Apparel any trade name, trademark, mark, logo or alike of any person, company or business entity as foreseen in the Pro Circuit Handbook.
 - c. I shall not display at any Competitions, including on my body, any commercial, promotional, political or charitable message (unless specifically permitted in the Pro Circuit Handbook) or anything that can reasonably be interpreted as being obscene or otherwise contrary to FIBA's values as enshrined in the FIBA Code of Ethics, failing which I will not be allowed to play.
- 9. I hereby waive any right to prize money and any such prize money shall go to the International Basketball Foundation to the extent that
 - a. I am subject to rules contractual, statutory or otherwise which prohibit me from being paid prize money for the Competitions (e.g. because I have "amateur" status); or
 - b. I fail to cash in the prize money within 1 month after I have been provided with the respective cheque, promissory note or the like.
- 10. FIBA, as administrator of play.fiba3x3.com, may update or complete my profile on play.fiba3x3.com with respect to my date of birth, height, weight, apparel and shoe size, photo, nationality and city/country of residence.
- 11. If and once my Validated Team benefits from a Privileged Invitation, i.e. obtains a spot in a Challenger via Automated Allocation, or accepts a FIBA Wild Card or Performance Slot or Replacement or Stand-by to a Pro Event, or becomes a Hard-Seeded Team for the Season (whichever comes first), I shall not play thereafter, until the end of the same Season, in any 3-on-3 basketball competition other than FIBA 3x3 Official Competitions and those FIBA-endorsed 3x3 events marked in play.fiba3x3.com as qualifying to a Pro Event, unless FIBA so approves, pursuant to the procedure and criteria set out in Annex 3 to the Pro Circuit Handbook. If I violate the foregoing obligation, I will be excluded from playing in Pro Events via a Privileged Invitation for 24 months following the violation, my individual ranking points will not be taken into account for Team Ranking purposes during the same time period, and I will pay an indemnity of up to CHF 10.000 for each Pro Event in which I participated during the Season based on a Privileged Invitation.
- 12. If my Validated Team becomes a Hard-Seeded Team for the Season, I shall during that Season, if requested by FIBA, wear the footwear provided by FIBA free of charge in all Pro Events, and will not be allowed to play in such events without such footwear.
- 13. I understand and consent that the use of my Personal Data will be in compliance with the General Data Protection Regulation (GDPR) and all relevant Swiss legislation. I acknowledge that FIBA's legal basis for holding and processing my Personal Data is FIBA's legitimate interest for the protection of my health. I have been advised that my Personal Data will not be shared with any other third parties except the medical expert engaged by FIBA and the related local authority and will be destroyed by FIBA at the end of the following year. - 14. This Entry Form shall be valid from the date of signature until the end of the year.
- 15. I agree that this Entry Form and any obligations and disputes arising out of or in connection with it shall be governed by and construed pursuant to Swiss law without its conflict of laws rules. I agree that any dispute, controversy or claim arising out of or in connection with this Entry Form, the Competitions and/or any other 3x3 competition shall be submitted exclusively to the Court of Arbitration for Sport (CAS) and resolved definitively in accordance with the Code of sports-related arbitration. The arbitration shall be governed by Chapter 12 of the Swiss Act on Private International Law (if I am domiciled in Switzerland, I waive the application of the third part of the Swiss Code of Civil Procedure). The seat of the arbitration shall be in Lausanne, Switzerland. The language of the arbitration shall be English. I shall not and I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, including provisional measures, in any other court or tribunal.
